
AGRONOMIC FEATURES

The Cross C41001/Impala.

LRPB Oryx is a high yielding ASFT (soft) classified wheat that has been approved for release by Allied Mills and Arnotts as a suitable soft wheat variety that meets all their quality requirements. LRPB Oryx is based on the proven genetics of LRPB Impala.

Like Impala it is well suited to main season planting in dryland and supplimentary irrigation soft wheat systems. LRPB Oryx has demonstrated reduced canopy heights over its Impala parent to aid in harvest efficiency along with improved disease traits.







Results of LongReach Plant Breeders trials have consistently shown Oryx to be marginally quicker to maturity than Impala making it a genuine Early-Mid Maturing variety. LRPB Oryx shows similar adaptability and yield to Impala with improvements in agronomy and leaf rust to meet the needs of Northern Impala growers.

PLANT BREEDERS RIGHTS

Each time a grower purchases seed of LongReach Oryx the grower agrees to comply with the Variety Licence and Royalty Agreement, including agreement to pay the EPR of \$3.75 per tonne (GST excl). EPR is payable on all grain production, except on seed retained by the grower for replanting by the grower. The majority of the EPR will be paid by Advanta Seeds to the Breeder (LongReach Plant Breeders) for investment in future wheat breeding programs.
