An improved yielding specialty Noodle wheat with ANW classification in South Eastern and Northern Zones

Significantly quicker in maturity than the established eastern states Noodle variety Rosella

11-14% average yield increase over Rosella from 6 years of LongReach Soft/ Noodle trials in NSW

Excellent Stripe Rust (RMR), Leaf Rust (R) and Stem Rust (MR) resistance

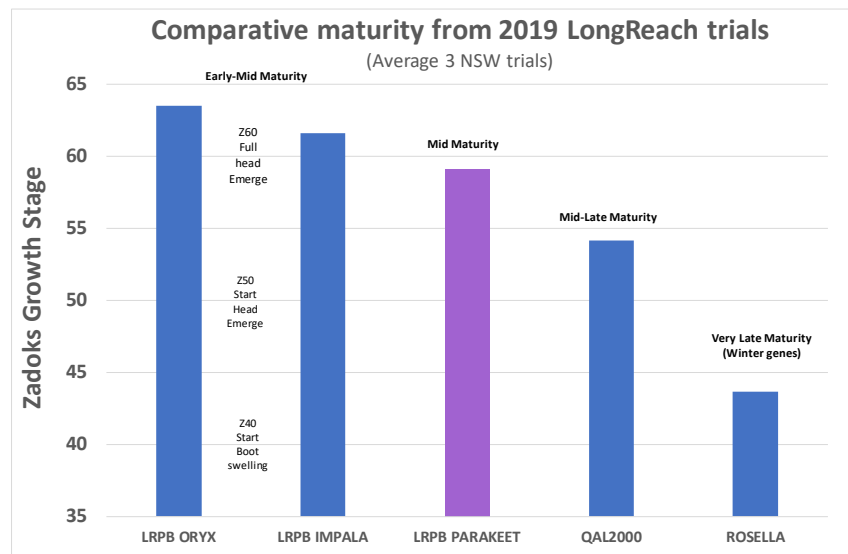

## AGRONOMIC FEATURES

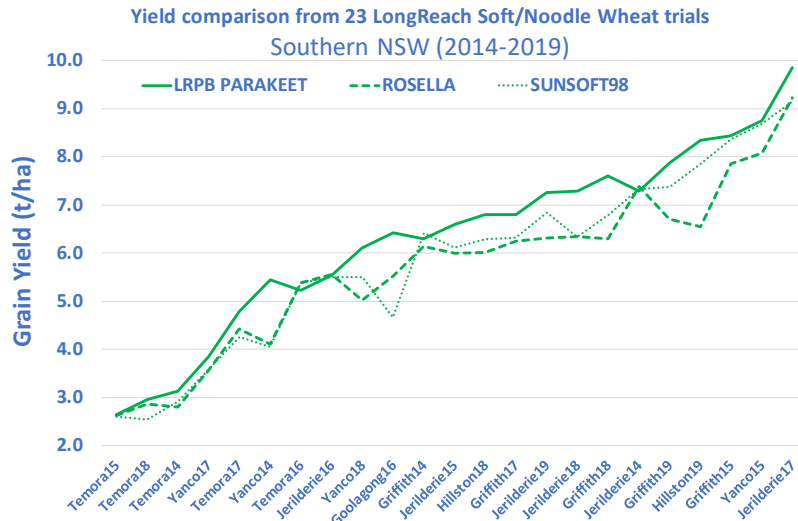
LRPB Parakeet is an improved yielding ANW (Noodle) classified wheat that has been approved for release by Allied Pinnacle and Arnotts as suitable to their quality requirements. LRPB Parakeet is mid-season in maturity to suit the main season May planting window. Mid maturity means LRPB Parakeet has a wide potential growing area, while the established Noodle wheat Rosella; with its longer maturity, is restricted to irrigation and longer season environments.

LRPB Parakeet has good plant vigour, erect early growth and medium-tall height at maturity. LRPB Parakeet has sound standability under most conditions, with some later season lodging indicating specific management may be required in very high yield situations (>8t/ha).

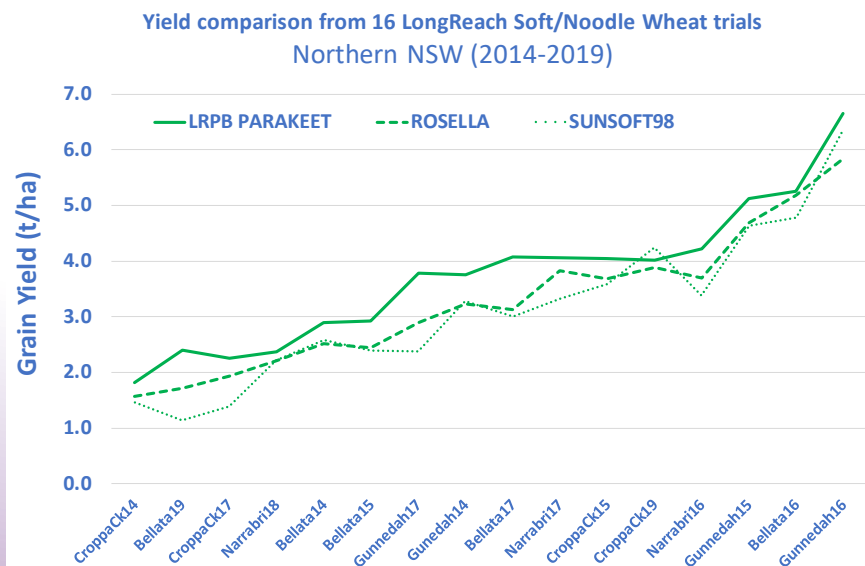


## YIELD PERFORMANCE

Southern NSW trials show LRPB Parakeet significantly out yielded established eastern states Noodle wheats Rosella (11%) and Sunsoft 98 (8%) across a wide range of yield environments.



Northern NSW trials show LRPB Parakeet significantly out yielded established eastern states Noodle wheats Rosella (14%) and Sunsoft 98 (19%) across a wide range of yield environments.



### PLANT BREEDERS RIGHTS

LongReach Parakeet is protected by Plant Breeders Rights (PBR). In regard to propagating material (planting seed) of this variety, any unauthorised commercial production or reproduction, conditioning for propagation, offering for sale, sale, import, export or stocking of propagating material is an infringement under the Plant Breeders Rights Act 1994. No grower to grower trading of seed of LongReach Parakeet is allowed.

### End Point Royalty (EPR)

Each time a grower purchases seed of LongReach Parakeet the grower agrees to comply with the Variety Licence and Royalty Agreement, including agreement to pay the EPR of \$3.75 per tonne (GST excl). EPR is payable on all grain production, except on seed retained by the grower for replanting by the grower. The majority of the EPR will be paid by Advanta Seeds to the Breeder (LongReach Plant Breeders) for investment in future wheat breeding programs.
