## **Notice of Assignment**

We refer to the:

- Seed Licence and Royalty Agreements between Advanta Seeds Pty Ltd (ACN 010 933 061) trading as Pacific Seeds (Advanta Seeds) and growers of wheat varieties (Growers) which are owned or controlled by LongReach Plant Breeders Management (ACN 099 112 991) (LRPB); and
- 2. Farmer to Farmer Licence Agreement imposed upon Growers as a condition to the sale of seed of the LRPB Variety from one Grower to another Grower,

(together, the **Grower Agreements**), pursuant to which the Growers must pay an end point royalty to Advanta Seeds (**End Point Royalty**).

Following an internal restructure of operations, the Grower Agreements as they relate to the LRPB Varieties have been assigned from Advanta Seeds to LRPB with effect from 1 September 2023. The purpose of this letter is to notify you that:

- Advanta Seeds has assigned all of its rights, title and interests in the Grower Agreements as they relate to the LRPB Varieties to LRPB with effect from 1 September 2023;
- From 1 September 2023, LRPB is entitled to receive all accrued and accruing End Point Royalties for the LRPB Varieties from the Growers under the Grower Agreements regardless of whether such End Point Royalties accrued prior to or accrue after the date of this letter, and will undertake the necessary actions to collect such End Point Royalties; and
- Advanta Seeds and LRPB irrevocably direct you, from 1 September 2023, to pay all End Point Royalties for the LRPB Varieties payable pursuant to Grower Agreements to LRPB.

The Annexure to this letter sets out a list of all LRPB Varieties impacted by this assignment.

Along with the assignment of Grower Agreements to LRPB related to LRPB Varieties, Advanta Seeds has also appointed LRPB to collect End Point Royalties for EGA Gregory. For the



avoidance of doubt, End Point Royalties for EGA Gregory will now be collected by LRPB on behalf of Advanta Seeds.
